### REAL ESTATE UPDATE

As you can see on page 11 – the Real Estate market is HOT! You can always tell by how short the Days on Market have gotten. The one bedrooms rocked the sales that closed in October but the units that went under contract last month were largely 2 bedrooms and a lot were corner units, which had been slow-moving for the past few months.

Prior to October, we were used to our single family homes and townhomes selling within days, but our condo listings were taking a little longer. Not anymore! We are getting offers at or over list price for remodeled condos now too. The operative word is "remodeled". Condos with original kitchen and/or baths, especially if they have carpet and wallpaper, are still a tough sell unless they are priced right. Some buyers have the funds to put in the 30K or more that it takes to remodel an average Hillcrest unit but most do not. With mortgage rates still around 3%, it almost doesn't make sense to pay cash. However, cash buyers are willing to pay over appraised value for something that suits their personal tastes and saves them time and effort.

Any and all trades that service the Real Estate industry are busier than ever: mortgage lenders, appraisers, inspectors, plumbers, painters, electricians etc. New home contractors are experiencing a shortage of lumber. Anyone buying appliances right now know how long it is taking to get them delivered. Being confined apparently has inspired people to want to beautify their surroundings.

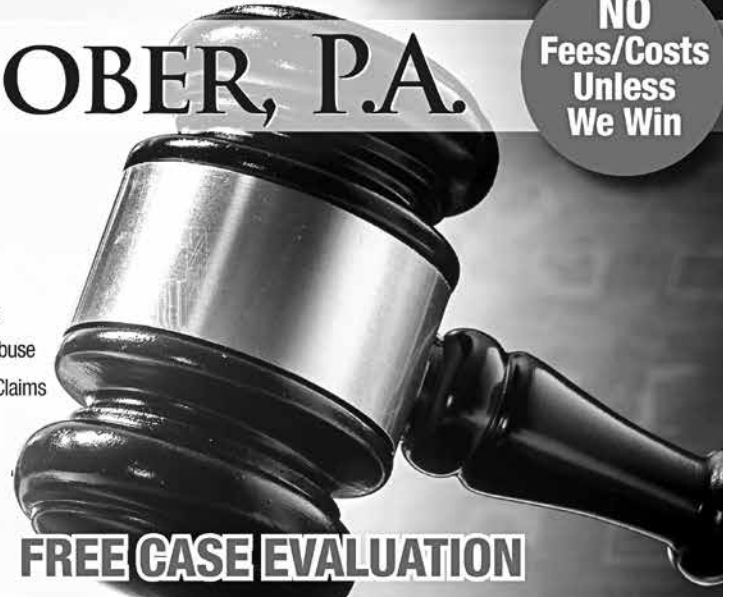

## BEWARE OF POISON - By Steve Schneider



A Hillcrest pooch is back home and healthy after eating rat poison she found in the bushes in back of her low-rise building this fall.

The dog spent at least 30 hours at a local vet hospital. The life-saving treatment cost her master almost \$1,500.

The small, eight-year-old pet, who consumed enough rat poison to kill her, lived to spend the upcoming holiday season with the unit owner who loves her.

Inside Hillcrest is not naming the owner, who gave the following account:

Her dog was walking in back of their building when she disappeared for about five minutes. When the pooch appeared again, she had green slime in her mouth.

The unit owner investigated. She found green balls, that looked like candy, in the bushes in back of their building. Eventually, the woman learned the item was a rat poison that she identified over the internet.

Authorities confirmed it was rat poison. They told her the poison could hurt a dog with more heft, but would likely kill the Hillcrest hound, who weighs 13 pounds.

The dog paid no mind to what the experts said, although she was not used to being away from her owner while in the hospital. Otherwise, though, the animal did not give in to the potentially deadly concoction.

This experience caused the unit owner to reach out to Inside Hillcrest. She wants people to be careful and thoughtful.

Of course, the woman understands that people are concerned that nearby construction of new housing has forced critters to flock to our buildings for hiding places.

But, she says, rat poison is a serious, deadly brew of chemicals that people should not place on Hillcrest property.

"We don't want dogs and cats, and other animals, including squirrels, to die because someone put down poison," she said.

The woman added that young children -- visiting relatives and exploring -- could also find the poison and put it in their mouths.

"That would be an even greater tragedy," she said, adding residents should speak with their condo president before taking action to deal with the critters. "And make sure you post information at your building so everyone knows what you did."

# November Kitchen Korner - by Cindy Abraham

Again, I will not be printing traditional Thanksgiving recipes. We all have our own family traditions. When I was a kid, we never had turkey; none of us really liked it. We had chicken or Cornish hens. When I started making turkey for Thanksgiving, I had to make two kinds of stuffing because not everyone liked my Oyster-Sausage stuffing – the kids preferred Stove Top. I had to serve jellied and chunky cranberry sauce because my step-father liked jellied, and corn as well as green beans to keep everyone happy. The only thing everyone in the family agreed on was the pull-apart garlic bread.

With the pandemic and family spread far and wide, the only thing about a traditional dinner I will miss are the leftovers. I love a good turkey, mayo, stuffing, cranberry sandwich. I do have a couple of recipes that you may want to use when you put together whatever it is you decide to make. I am including a good chicken recipe that is Thanksgiving-ish also.

## Pull Apart Garlic Bread

Basically, you just take your favorite frozen rolls and put them in a glass baking dish. Toss them with oil, butter and fresh garlic and minced parsley. Let them thaw in the baking dish and rise. Then bake them according to the package directions.

## Stuffing Mini-Muffins

These are a hit because they are individually made. You can use a mini-muffin pan (makes about 16) or a regular muffin pan to make 9. Leftovers are great too.

- 1 ½ cups stuffing
- 1 TBS extra virgin olive oil
- 1 TBS butter
- 1/3 cup minced onion
- 1/3 cup minced celery
- 1 sweet Italian sausage (no skin and you can use turkey sausage)
- 3 minced garlic cloves
- ½ tsp dried sage
- ¼ cup finely chopped small apple
- 2 TBS chopped cranberries
- 2 large eggs beaten
- 1 TBS chicken broth



Pre-heat oven to 350. Spray mini-muffin pan with non-stick butter spray. Melt butter in a large skillet and add oil. Add onion and celery and cook over medium high heat. Stir until golden, about 5 minutes. Add sausage, garlic and sage. Break up sausage and stir until meat is cooked through. Remove from heat.

Pour mixture into large bowl and add stuffing, apple, beaten eggs and broth. Stir well. Pack stuffing into the muffin cups and bake for 25 minutes until golden. Remove from oven and let cool for 5 minutes. Serve warm. You can pre-make muffins, let cool completely, put them in a container and keep in the refrigerator until ready to serve. Warm them up before serving.

Oyster Sausage Stuffing Muffins– use the same recipe



as above but substitute 1 8-oz container of shucked oysters instead of apple and cranberry

## Stuffed Glazed Chicken Breasts or Thighs

4 skin-on breasts or thighs. The stuffing is going to be stuffed under the chicken skin – be careful to lift carefully so as not to tear the skin. Stuffing:

- 1 diced red or green apple (don't peel unless you want to)
- ¼ cup golden raisins, currants or dried cranberries
- ¼ cup chopped pecans or walnuts
- ½ cup stuffing (or cut up 2 pieces of toast)
- 3 TBS chopped onion
- 1 Italian sausage (skin removed)
- 1 tsp dried sage

Preheat oven to 350. Crumble the sausage in heated skillet with oil and brown. Add onion and sage and stir until onion is translucent. In a bowl combine fruits, nuts, and stuffing. Add sausage mixture and stir well and let cool. Use your fingers to carefully lift the skin away from the meat to stuff. Secure with toothpicks. Place chicken on roasting pan rack and brush with glaze. Bake for one hour.

## Glaze:

- ¼ cup OJ concentrate
  - ¼ cup butter
  - 1/3 cup apple jelly
  - ¼ cup dry sherry (or apple or cranberry juice)
- Combine and melt in a pan so you can brush on during cooking and have enough to pour on top at the end.

And because apples are cheap right now and this recipe is so easy AND healthy that I have made it four times this month, here is a nice dessert recipe.

## APPLE CRUMBLE (you need a 8" square pan with at least 2" sides)

- 3-4 pounds apples, cored, peeled and cut into 3/4" chunks
- 2 TBS packed brown sugar plus 1/3 cup divided
- 2 TBS lemon juice
- 1 tsp salt divided
- ½ tsp cinnamon
- 1 cup wheat all-purpose flour
- ½ cup sliced almonds chopped fine (I use the food processor)
- 5 TBS unsalted butter melted
- 2 tsp vanilla extract
- 2 tsp water

Place one oven rack in the upper middle and one on the lowest position and heat oven to 400 degrees.

Toss apples with 2 TBS brown sugar, lemon juice, ½ tsp salt and the cinnamon in a large bowl and then pour them into the 8-inch baking pan and press into an even layer. Cover tightly with foil, place baking pan on a rimmed baking sheet and place on the lower rack for 35 minutes

Whisk flour, almonds, ½ cup brown sugar and ½ tsp salt in a medium bowl until combined. Add melted butter, vanilla and water and (wearing gloves), mix until crumbly and no dry flour remains.

Remove sheet from oven and smooth the top of the apples with a spatula. Scatter the topping evenly over the apples, breaking up any clumps larger than a marble.

## EMOTIONAL SUPPORT ANIMALS AND SOME NEW FLORIDA LAWS

From Eric Glazer's CONDO CRAZE AND HOA'S BLOG

Are there problems in your Florida Condo and HOA? If so, call in and tell attorney Eric Glazer from Glazer and Associates, P.A., every Sunday at 11 AM. Get your questions answered live & on the air. New Florida Statute 760.27 defines "Emotional support animal" as an animal that does not require training to do work, perform tasks, provide assistance, or provide therapeutic emotional support by virtue of its presence which alleviates one or more identified symptoms or effects of a person's disability." So, yet another owner or renter wants an emotional support animal. What must they prove? Let's see what the new Florida Statute 760.27 says:

1. A disability "a physical or mental impairment which substantially limits one or more of such person's major life activities such as caring for oneself, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning, and working. And....

2. That the pet alleviates the disability and is necessary to now use and enjoy the dwelling.

### Can the Association Ever Deny The Request?

Unless otherwise prohibited by federal law, rule, or regulation, a housing provider may:

(a) Deny a reasonable accommodation request for an emotional support animal if such animal poses a direct threat to the safety or health of others or poses a direct threat of physical damage to the property of others, which threat cannot be reduced or eliminated by another reasonable accommodation.

### (b) Can The Association Ask For Medical Records? NO

Notwithstanding the authority to request information, the association may not request information that discloses the diagnosis or severity of a person's disability or any medical records relating to the disability. However, a person may disclose such information or medical records to the association at his or her discretion.

### Suppose the Disability is Not Apparent?

If a person's disability is not readily apparent, the association can request reliable information that reasonably supports that the person has a disability. Supporting information may include:

#### RELIABLE DOCUMENTATION

1. A determination of disability from any federal, state, or local government agency.

2. Receipt of disability benefits or services from any federal, state, or local government agency.

3. Proof of eligibility for housing assistance or a housing voucher received because of a disability.

4. Information from a health care practitioner, a telehealth provider, or any other similarly licensed or certified practitioner or provider in good standing with his or her profession's regulatory body in another state but only if such out-of-state practitioner has provided in-person care or services to the tenant on at least one occasion. Such information is reliable if the practitioner or provider has personal knowledge of the person's disability and is acting within the scope of his or her practice to provide the supporting information.

5. Information from any other source that the housing provider reasonably determines to be reliable.

### Can a person Have More Than One Emotional Support Animal?

If a person requests to keep more than one emotional support animal, the association may request information regarding the specific need for each animal.

### Can The Association Require Proof That The Animal Is Properly Vaccinated?

The Association may require proof of compliance with state and local requirements for licensing and vaccinating each emotional support animal.

### Are There Limitations On What An Association May Ask Someone Who Wants An Emotional Support Animal?

A housing provider may develop and make available to persons a routine method for receiving and processing reasonable accommodation requests for emotional support animals; however, a housing provider may not require the use of a specific form or notarized statement, or deny a request solely because a person did not follow the housing provider's routine method.

### What about these websites that offer to classify your animal as an emotional support animal for a fee?

An emotional support animal registration of any kind, including, but not limited to, an identification card, patch, certificate, or similar registration obtained from the Internet is not, by itself, sufficient information to reliably establish that a person has a disability or a disability-related need for an emotional support animal.

### A DOCTOR CAN NOW BE DISCIPLINED FOR:

Providing information, including written documentation, indicating that a person has a disability or supporting a person's need for an emotional support animal without personal knowledge of the person's disability or disability-related need for the specific emotional support animal.

### AND SO CAN THE PATIENT:

817.265 A person who falsifies information or written documentation, or knowingly provides fraudulent information or written documentation, for an emotional support animal or otherwise knowingly and willfully misrepresents himself or herself, through his or her conduct or through a verbal or written notice, as having a disability or disability-related need for an emotional support animal or being otherwise qualified to use an emotional support animal, commits a misdemeanor of the second degree. In addition, within 6 months after a conviction under this section, a person must perform 30 hours of community service for an organization that serves persons with disabilities or for another entity or organization that the court determines is appropriate.

### What if The Animal Damages Association Property?

(4) LIABILITY.—A person with a disability or a disability-related need is liable for any damage done to the premises or to another person on the premises by his or her emotional support animal.

## IN OUR BACKYARD – by Meredith Shuster, Hillcrest 26

In Our Backyard, we are seeing the “change of seasons”. More birds have begun returning as the migration from the north is underway. Next month’s article will feature these “snowbirds”. Reptiles have gone through the hatching stage and little lizards are all over the place. Squirrels are up to their antics and “speed dating” amongst the species is in progress for nest building and eggs to be laid over the next couple of months. As I walk the “Hillcrest rectangle” (Hillcrest Drive to 46th Avenue, to Washington St. to Park Rd to Hillcrest Drive) the doldrums of summer are slowly lifting to the sounds of wildlife getting more active.

In my solitary musings, I reflected on the significance of our backyard creatures. Many indigenous cultures would study the animals that crossed their path as “signs” from the spirit world. For the most part, humans and animals go their own way; but now and again, a creature will catch our attention. In other instances, an animal one would rarely see makes an appearance. Finally, for no obvious reason, a “connection” occurs. You may have experienced this in choosing a pet. A puppy, a kitten, or some other animal seems drawn to you and vice versa. An inner feeling tells you that this is the animal for you. Is there more meaning to these instances? Looking at the more common inhabitants we encounter; lizards, Ibis, ducks and squirrels, let’s explore what they might symbolize. Aww come on, go with me – just for the fun of it.

Starting with the numerous lizards that scurry across our paths they naturally flee as we approach. That trait has been interpreted as a warning to “flee danger or unhappy circumstances” to the person who sees them. If a lizard pauses and allows you to see it, the message was “good luck” as lizards were creatures that could hide well. Their message is “unexpected good fortune is coming to you.” (If this happens to you, buy Lotto tickets.) If these reptiles make you squeamish, try looking at them in a spiritual light. You don’t have to like them, but it does make it easier to co-exist.

The Ibis is the white bird with the long rounded beak that we see in clusters around our grassy areas. They eat a tremendous amount of insects. They are sociable and come back to familiar feeding grounds year round. They are considered sacred birds of spirituality and wisdom.

In Ancient Egypt they are depicted as a god with a human body and bird head. In amongst the white Ibis, some are mottled colored.

Ibis are born dark and turn white as they mature. This was thought to symbolize ‘ignorance when we are born evolving into knowledge and wisdom as we age. They group around other species as we often see them with the ducks symbolizing our ability to “get along” even with those different from us. (Take that Democrats and Republicans). Overall, they symbolize our higher spiritual ideals.

Ducks are symbolic of our emotional states. Spiritually, they remind us to stay connected to our emotions and to “go with the flow” or glide above the water of life with calm and confidence. It is written if a duck appears in your dreams to examine your current situation to determine if you are trying to “duck” something. Their message is to “pay attention” to our emotional needs. They are often thought of as a “wake up call” to be aware of negativity and to take steps to avoid stressful circumstances. (Anyone else no longer watching the news?) A very timely message in our COVID world.

The squirrel surprised me as I researched its spiritual meanings. They symbolize being aware of one’s finances and preparations for emergencies. They represent “having fun” but not at the expense of not having enough resources for that proverbial “rainy day”. Seeing a squirrel in a dream was interpreted as a warning to be prepared. Simple things like being sure your car is maintained before taking a trip or handling a simple leak repair before the pipe bursts are the kind of warnings they impart. I for one, have watched two squirrels scampering in the lawn behind my unit reminding me of Chip and Dale, the cartoon chipmunks.

They look like they are having such fun and at times are more entertaining than what was on TV. In these long days of isolation where socializing is both longed for and scary, take a moment and contemplate the wonder of where we live. There are places more rustic, less crowded, better developed and landscaped but I can’t help but notice the creatures that are in our backyard all symbolize positive things. Just another reason why Hillcrest is a “Hidden Jewel.”

The same info above is needed for a condo unit except NO 4 point inspection is required. The appraised value would be needed if the condo is new purchase and there is a mortgage. This is because most lenders minimum coverage requirement is 20% of the appraised value. If the building is 5 or more stories, we can usually use the building’s commercial wind mitigation inspection. If this can be obtained, the customer would not have to pay for their own wind mitigation inspection (called a windmit) unless they are trying to qualify for opening protection credit as commercial windmits don’t show opening protection credit unless the entire building qualifies. For new purchase or no prior

insurance, a conversation with the customer regarding what limits are most appropriate for them is needed prior to quoting.

**2021 Homestead Exemption**

All qualified Florida residents are eligible to receive a Homestead Exemption on their homes, condominiums, co-op apartments, and certain mobile home lots. To qualify for Homestead Exemption, you must own and make the property your permanent residence on January 1 of the year for which you are applying for this valuable exemption. Pursuant to Florida law, all assessments and exemptions are based upon the status of the property on January 1. If you purchased and/or made the property your permanent residence in 2020 and have not applied for Homestead Exemption, you can apply for 2021 exemptions at any time – there is no need to wait until 2021 to file your exemption application with the Property Appraiser's Office. You can easily apply online at <https://web.bcpa.net>

**The timely deadline to file for all 2021 exemptions is March 1, 2021.** You must make the property your permanent residence by January 1, 2021 in order to qualify; however, you have until March 1 to timely file your application with the property appraiser's office. The late filing deadline for all 2021 exemptions is September 20, 2021. For information about all the other exemptions available to qualified applicants, please visit the "Exemptions & Classifications" page on our website <https://web.bcpa.net/bcpaclient/#/Homestead>.

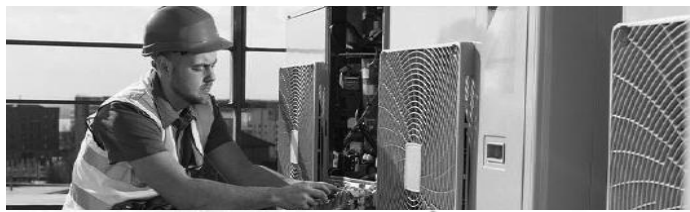
Once approved, your Homestead Exemption automatically renews each year provided there is no change in the ownership or use of the property. If you have already applied and been approved for Homestead Exemption at your current property, you do not need to reapply for this exemption. You will receive a Homestead Exemption renewal card next month to keep for your records.
